NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell, and release, in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

All that piece, parcel or tract of land lying and being in Fairview Township, Greenville County, South Carolina, on the Neely-Ferry Road, adjoining the Unity Church property and the Unity Church cemetery, containing Fifty-Seven and Two-Tenths (57.2) acres, according to survey and plat made by J. MacRichardson, Reg. Land Surveyor, in March, 1953 and bounded on the north by lands now or formerly of Unity Cemetery, Maude Boyd, on the east by Maude Boyd and the estate of L. R. Peden, on the south by the L. R. Peden estate and on the west by lands of N. A. Culbertson, George Putnam and Unity Church.
