All that piece, parcel or lot of land in the City of Greenville, Greenville County, State of South Carolina, lying and being on the Northern side of Perry Avenue near the intersection of Perry Avenue and North Memminger Street, and having, according to a Plat by J. C. Hill, Surveyor, dated October 22, 1948, the following metes and bounds, to-wit:
