"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Sunset Drive in the City of Greenville, being shown as lot #14 on plat of Section C of Rockwood Park, made by Pickell & Pickell in March, 1951, recorded in plat book "Y" at Page 95, and described as follows:

BEGINNING at a stake on the Western side of Sunset Drive 234 feet North from Meyers Drive at corner of lot #15 and running thence with the line of said lot N. 62-43 W. 256 feet to a stake; thence N. 55-30 E. 96.1 feet to a stake at corner of lot #13; thence with the line of said lot S. 62-43 E. 210 feet to a stake on Sunset Drive; thence with the Western side of Sunset Drive S. 27-17 W. 85 feet to the beginning corner; being the same property conveyed to the mortgagors by deed recorded in deed book 472 at page 357.
