"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot 155, as shown on a revised plat of Sherwood Forest, recorded in Plat Book GG at Page 2 and 3, and being more particularly described according to said plat as follows:
