"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about two and one-half miles m from the Cityof Greenville, in subdivision known as Sans Souci and being known and designated as lot No. 22, according to plat recorded in Flat Book G at Page 160, and having the following metes and bounds, to-wit:
