with interest thereon from date at the rate of five per centum per annum, said principal and interest to be repaid:PAYABLE at the office of the payee in Jacksonville, Florida, or at such other place as may be designated by the molder hereof in monthly installments of \$98.65 each, payable respectively on the 4th day of June next hereafter and on the same day in each succeeding month until paid in full, said payments to be first applied in payment of monthly interest and the balance thereof upon and in reduction of principal, with interest thereon from date at the rate of Five per cent, per annum, to be computed and paid monthly, until paid in full, all principal and interest not paid when due to bear interest at the ate of 7% per annum.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lots to 7 inclusive as shown on plat of property of Cuttino Heirs, recorded in Plat Book J at Page 121, and being more particularly described according to a recent survey prepared by J. C. Hill, dated April 27, 1953, as follows:

"BEGINNING at a point in the ditch on the East side of Paris Road (formerly McCarter's Shop Road), which point is 220 feet North of an unnamed street, and is the joint front corner of lots 7 and 8, as shown on said recorded plat and running thence with the Paris Road, due North 172 feet to an iron pin; thence S. 79-26 E. 278.3 feet to an iron pin in line of lot 216; thence with the line of said lot, S. 14-45 W. 192.3 feet, more or less, to a point in line of lot 145; thence N. 74-30 W. 235 feet to the point of beginning."
