C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs new City Limits of Green), and being known and designated as Lot No. 28 on plat of Development No. 2, Victor-Monaghan Company, Division of J. P. Stevens & Company, Inc. Green Plant, prepared by Dalton & Neves, Engineers, April 1947, and recorded in the Office of R. M. C. for Greenville County in Plat Book "P", page 119, and having according to said plat, the following metes and bounds, to wit:-
