

State of South Carolina MORTGAGE OF REAL ESTATE
To All Whom These Presents May Concern:
I, Aughty G. Laughridge, Jr., of Greenville County, SEND GREETINGS: WHEREAS, I the said Aughty G. Laughridge, Jr.
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Ten Thousand, One Hundred and No/100 (\$ 10,100.00) four (4%) Dollars, with interest at the rate of ***/*(6%)** per centum per annum, to be repaid in installments of Sixty-One and 21/100 (\$ 61.21) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.
NOW KNOW ALL MEN. That I , the said Aughty G. Laughridge, Jr.
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me, the said Aughty G. Laughridge, Jr. in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of Donnan Road (formerly known as the Edwards Road) and on the North side of Lee Road near the City of Greenville, Chick Springs Township, being shown as a portion of Lot 12 on a plat of property of W. S. Bradley made by Dalton & Neves, Engrs., May 1948, recorded in the R. M. C. office for Greenville County, S. C. in Plat Book K page 148 (also being shown as Lot 2 on plat of property of Richard S. Cresswell, made by C. C. Jones, Surveyor, recorded in Plat Book Page , Page , and having, according to said recent survey, the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the center of the Donnan Road at the intersection of said Donnan Road with the Lee Road and running thence along the center of Donnan Road, N. 1-50 E. 200 feet to an iron pin in the center of said road; thence N. 88-10 W. 327.5 feet to an iron pin; thence S. 14-16 E. 292.9 feet to an iron pin on the north side of Lee Road; thence with the north side of Lee Road, N. 73-00 E. 256.3 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to me under the name, A. G. Laughridge, Jr., by Richard S. Cresswell by his deed dated May 9th, 1953, not yet recorded."
