NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oaklawn Township, being taken from the Southeast corner of Tract # 7, as shown on plat of property of Salt Ware Property, recorded in Plat Book E at Page 152, and being more particularly described by metes and bounds, as follows:

"BEGINNING at a pin in the center of the Greenville-Augusta Highway, at the Southeast corner of original tract # 7, as shown on above referred to plat and running thence with center of road in a Northwesterly direction 210 feet to pin on Augusta Road; thence in a Northwestern direction 435 feet to iron pin in line of property now or formerly owned by J. B. Martin; thence continuing with line of said property in a Southeasterly direction 210 feet to iron pin in line of tract 6; thence with line of tract 6, S. 73-45 E. 435 feet to iron pin in center of Augusta Road, point of beginning.
