"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of U. S. Highway, No. 25 being shown as the Eastern portion of Tract # 1, as shown on plat of Estate of J. B. Hawkins, Jr., made by Dalton & Neves in January 1949, being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin at the intersection of U. S.
