Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of			

Twenty-five and No/100 - - - - - - - - - - (\$ 25.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That we, the said G. C. Miller and Maud V. Miller

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to

the said G. C. Miller and Maud V. Miller in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, now near the corporate limits of the City of Greenville, being known and designated as Lot No. 25 of a subdivision known as Hudson Acres, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book Y, at page 39, and having, according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeasterly side of Greenwood avenue, joint front corner of Lots Nos. 24 and 25, and running thence S. 37 E. 263.7 feet to an iron pin; thence N. 40 E. 155 feet to an iron pin, joint rear corner of Lots No.s 25 and 26; thence N. 34-30 W. 240.1 feet to an iron pin at the joint front corner of Lot No.s 25 and 26, at the intersection of Woodcrest Circle and Greenwood Avenue; thence S. 74-50 W. 50 feet; thence S. 29 W. 50 feet; thence S. 47-30 W. 70 feet to an iron pin at the beginning corner."

The above described lot is the same as conveyed to us by James M. Bruce by deed dated Feb. 20, 1953, and recorded in the R. M. C. office for Greenville County in Deed Book 473 at page 263.
