"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, near the corporate limits of the City of Greenville, being known and designated as Lot No. 26 of a subdivision known as Woodland Hills according to a plat thereof prepared by Dalton & Neves, Engineers, in May, 1951, and recorded in the R. M. C. office for Greenville County in Plat Book Y, at page 60, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of Wildwood Road at the corner of Lot No. 25, and running thence along the line of that lot, N. 73-00 E. 170 feet to an iron pin in the rear line of Lot No. 24; thence along the line of that lot, N. 17-00 W. 100 feet to an iron pin at the rear corner of Lot No. 27; thence along the line of that lot, S. 73-00 W. 170 feet to an iron pin on the east side of Wildwood Road; thence along the east side of said Wildwood Road, S. 17-00 E. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Talmer Cordell by deed of even date herewith, not yet recorded."
