Now, Know ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: near the City of Greenville, on the eastern side of Welcome Street, being known and designated as a portion of Lots Nos. 17 and 18, as shown on a plat of a subdivision known as Welcome View, made by Piedmont Engineering Service, which plat is recorded in the R. M. C. Office for Greenville County, State of South Carolina, in Plat Book U, at page 55 and having, according to said plat, the following metes and bounds, to-wit:
