MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, C. E. Robinson, Jr. and R. M. Gaffney, of Greenville County, SEND GREETINGS:

WHEREAS, we the said

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Nineteen Thousand, Five Hundred and No/100 - - - (\$ 19,500.00) (five (5%) per centum, computed semi-annually Dollars, with interest at the rate of six/(6/%) per senting per annum, to be repaid in installments of

Gaffney in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 8, Block A, Lot No. 6, Block D, and Lot No. 9, Block D, of a subdivision known as Brookforest according to a plat thereof prepared by Piedmont Engineering Service, August, 1950, recorded in the R.M.C. office for Greenville County in Plat Book BB, page 41, and having, according to said plat, the following metes and bounds, to-wit:

LOT NO. 6, Block D: Beginning at an iron pin on the south side of Woodmont Circle the joint front corner of Lots 5 and 6, Block D, and running thence along the joint line of said lots, S. 11-44 E. 150.9 feet to an iron pin; thence S. 89-03 W. 71.8 feet to an iron pin, the joint rear corner of Lots 6 and 7, Block D; thence along the joint line of said lots, N. 11-44 W. 137.6 feet to an iron pin on the south side of Woodmont Circle; thence along the south side of Woodmont Circle, N. 78-16 E. 70 feet to the beginning corner.

LOT NO. 9, Block D: Beginning at an iron pin on the south side of Woodmont Circle, joint front corner of Lots 8 and 9, Block D, and running thence along the south side of Woodmont Circle, S. 78-16 W. 85 feet to an iron pin, joint front corner of Lots 9 and 10, Block D; thence along the joint line of said lots, S. 11-44 E. 145.8 feet to an iron pin; thence N. 65-41 E. 101.9 feet to an iron pin; thence N. 6-20 W. 20 feet to an iron pin, joint rear corner of Lots 8 and 9, Block D; thence along the joint line of said lots N. 15-26 W. 106.1 feet to an iron pin, the beginning corner.
