"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Grove Township, on the southeast side of Highway No. 29, and being known and designated as Lot No. 1 of a subdivision of the property of C. B. Dalton as shown on plat thereof made by Dalton & Neves in May of 1947 and recorded in the R. M. C. office for Greenville County in Plat Book AA, at page 189, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast side of Highway No. 29 at the corner of the lot now or formerly belonging to T. D. Simmons, and running thence S. 58-23 E. 204.7 feet to an iron pin at the corner of said lot on the northeast side of th railroad right-of-way; thence along said right-of-way, N. 27-42 E. 89.8 feet to an iron pin at the rear corner of Lot No. 2; thence along the line of that lot, N. 58-15 W. 198.5 feet to an iron pin at the corner of said lot on the southeast side of Highway No. 29; thence along the southeast side of Highway No. 29, S. 31-45 W. 90 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.

"The above described lot is the same lot as conveyed to H. E. Hawthorne and Lois G. Hawthorne by J. O. Jones by deed dated September 17, 1951 and recorded in
