(hereinafter referred to as Mortgagor) SEND(S) GREETING:

DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, at the Southwestern corner of the intersection of Lee Road and Mayfair Drive and being shown as Lots 1 and 2 of Block D of Mayfair Estates, as per plat recorded in Plat Book S at page 72, and having according to said plat the following metes and bounds, to wit:

"BEGINNING at an iron pin on the South Side of Lee Road at joint front corner of Lots 2 and 3, and running thence with line of Lot 3 S. 16-38 E. 150 feet to iron pin in line of lot 5; thence with line of Lot 5 N. 73-22 E. 96.4 feet to iron pin on West Side of Mayfair Drive; thence along side of Mayfair Drive; thence along the western side of Mayfair Drive N. 15-15 W. 135 feet to an iron pin; thence around the curve of Mayfair Drive and Lee Road (the chord of which is N. 59-56 W. 21 feet) to iron pin on the Southern Side of Lee Road; thence with the southern side of Lee Road S. 73-22 W. 85 feet to the beginning corner.

Said premises being the same as that conveyed to the mortgagor by Harold P. Hunt by deed recorded in Book 480, Page 351.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
