Robinson, as Trustee under B. M. McGee Trust Deed, his Successors and Assigns, forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known as Lot No. 82, Block C, as shown on Plat of City View, said Plat being recorded in Plat Book A, page 460, R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at a stake at the joint corners of Lots Nos. 81 and 82, said stake being 50 feet S. 1/2 W. from the corner of 0'Neal and Henderson Streets; thence along the joint line of Lots Nos. 81 and 82, N. 89-30 W. 150 feet to a stake on an alley; thence along said alley S. 1/2 W. 50 feet to corner of Lot No. 83; thence along the line of Lot No. 83, S. 89-30 E. 150 feet to a stake on Henderson Street; thence along said Street N. 1/2 E. 50 feet to the beginning corner.
