"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, and being more particularly described as follows according to plat of C. C. Jones, C. E., April 28, 1953:
