"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, situate just North of the Town of Simpsonville, on the West side of U. S. Highway # 276, being known and designated as lot 78, as shown on a plat of the subdivision of the land of F.M. Todd, said subdivision known as "Roland Heights", plat recorded in Plat Book S at Page 34, and having according to said plat the following metes and bounds, to-wit:
