NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northwest corner of Rogers avenue and Beacon Street, being shown as lot 43, on plat of property of B. E. Geer, made by W.M. Rast, "ay 1928, recorded in Plat Book G, at Page 237, and being described as follows:

"BEGINNING at a stake at the Northwest corner of Beacon Street and Rogers Avenue, and running thence with the Western side of Beacon Street, N. 5-50 W. 100.4 feet to a stake; thence N. 83-55 W. 73 feet to a stake, corner of lot 42; thence with line of said lot, 5-50 E. 100.4 feet to a stake on Rogers Avenue; thence with the Northern side of Rogers Avenue, S. 83-55 E. 73 feet to the beginning corner.
