"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the northwestern side of U. S. Highway No. 29 leading from Greenville to Greer, and being shown on plat of property of Mrs. J. G. Lindsey, dated June 1941, and having according to said plat the following metes and bounds, to wit:

"Beginning at an iron pin at the northeastern intersection of U. S.
