are incorporated herein by reference, in the principal sum of **Ten Thousand, Six Hundred**
Dollars (\$ **10,600.00**), with interest from date at the rate of **Four and One-Half** per centum
(**4½** %) per annum until paid, said principal and interest being payable at the office of

or at such other place as the holder of the note may designate in writing, in monthly installments of
Sixty-Seven and 10/100 - - - - - Dollars (\$ **67.10**),
commencing on the first day of **November**, 19 **53**, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **October**, 19 **73**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that lot of land, with the buildings and improvements thereon, sit-
uate on the northwest side of Friartuck Road, in the City of Greenville,
County of Greenville, State of South Carolina, being shown as Lot No.
54 on plat of Sherwood Forest, made by Dalton & Neves, Engineers,
August 1951, recorded in the R.M.C. Office for Greenville County, S.C.,
in Plat Book GG, at Pages 2 and 3, said lot fronting 70 feet along
the northwest side of Friartuck Road, and running back to a depth of
213.6 feet on the northeast side, to a depth of 199.1 feet on the
southwest side and being 92 feet across the rear.

The above described property is the same conveyed to the mortgagors
herein by deed of Virgil E. Lesley of even date and to be recorded
herewith.
