TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Sophie J. Tzouvelekas and Emanuel Tzouvelekas, by his General Guardian, Sophie J. Tzouvelekas  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Two Hundred and No/100

DOLLARS (\$ 4200.00 ), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville, at the Northwest corner of Aberdeen Drive and Sevier Street, being shown as lot 93, on plat of Park Hill, revised, made by Dalton & Neves, in May 1940, and described as follows:

"BEGINNING at an iron pin at the Northwest corner of the intersection of Aberdeen Drive and Sevier Street, and running thence with the Western side of Sevier Street, N. 28-50 E. 122.6 feet to an iron pin; thence continuing with Sevier Street, N. 31-10 E. 47.5 feet to an iron pin, corner of lot 99; thence with line of said lot, N. 60-28 W. 82 feet to iron pin, corner of lot 94; thence with line of said lot, S. 28-50 W. 170 feet to an iron pin on Aberdeen Drive; thence with the Northern side of Aberdeen Drive, S. 60-28 E. 80 feet to the beginning corner. "

This mortgage is executed by Sophie J. Tzouvelekas as General Guardian for Emanuel Tzouvelekas pursuant to authority of a decree signed by W. B. McGowan, County Judge in the case of Sophie J. Tzouvelekas/v. Emanuel Tzouvelekas, said decree being dated September 24, 1953.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
