at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents DO GRANT, BARGAIN, SELL and RELEASE unto the said Annie E. Owens, her heirs and assigns forever, the following described real estate:

the following:
ALL that piece, parcel or lot of land in O'Neal Township, Greenville County, South Carolina, situated about three miles Northwest of the Town of Greer, lying South of the County Road, and being all of Lots 65 and 66 on plat of the I. D. Bishop property, according to plat thereof prepared by H. S. Breckman, Surveyor, dated July 20, 1948, and having the following courses and distances, to-wit:

BEGINNING at a stake at the intersection of the old Rutherford Road with County Road, and running thence N. 75.45 E. 300 feet at joint corners of Lots 64 and 65 on line of old County Road; thence S. 6.20 E. 159 feet to a stake at the joint corners of Lots 61, 62, 66 and 67; thence in a westerly direction S. 87.49 W. 262 feet to a stake on edge of old Rutherford Road, joint corners of Lots 65 and 66; thence with the common lots of 65 and 66, on line of old Rutherford Road N. 24.30 W. 109 feet to point of beginning.

ALL that piece, parcel or lot of land in O'Neal Township, Greenville County, South Carolina, adjoining the above described property, having the following courses and distances, to-wit:

BEGINNING at a stake on the western edge of Rutherford Road, joint corner of Lots 66 and 67 and runs thence with the common line of these lots N. 87.49 E. 262 feet to a stake, joint corner of Lots 66 and 67, 61
