Greenville Township, Greenville County, State of South Carolina. being known and designated as Lot No. 4, Block C, according to plat of subdivision known as Kanatenah, recorded in Plat Book F, pages 130 and 131, R. M. C. Office for Greenville County, being situated north side of Oregon Street and more particularly described as follows:
