"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and on the east side of Judy Street, in the City of Greenville, and being known and designated as the western half of Lot No. 32 of the property of the Mountain City Land and Improvement Company as shown on plat thereof recorded in the R. M. C. office for Greenville County in Deed Book WW, at page 605, and having, according to a recent survey made by Dalton & Neves in February; 1952, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of Judy Street at the corner of Lot No. 33, which point is 86 feet north of the intersection of Dunbar Street, and running thence along the east side of Judy Street, N. 18-0 E. 43 feet to an iron pin at the corner of Lot 31; thence along the line of Lot 31, S. 76-00 E. 91 feet to an iron pin; thence S. 18-0 W. 43 feet to an iron pin in line of Lot No. 33; thence along the line of Lot 33, N. 76-00 W. 91 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
