NOW KNOW ALL MEN, That we, the said Roy R. Moon and Rachel D. Moon

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us

Roy R. Moon and Rachel D. Moon in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township, being known and designated as Lots #7, 8 and 9, Block E, of Buena Vista as shown on plats recorded in the R. M. C. office for Greenville County, S. C. in Plat Book "W", pages 11 and 29 and being described together according to said plats as follows:

"BEGINNING at a point on the Southern side of Mayflower Street, joint front corner of Lots 9 and 10, which iron pin is also 105 feet in an Easterly direction from the Southeast corner of the intersection of Mayflower Street and Elberta Street, and running thence with the line of Lot 10, S. 47-08 E. 170 feet to a point in the line of Lot #29; thence with the line of Lot 29, N. 53-52 E. 106.8 feet to a point, joint rear corner of Lots 7, 14, 15 and 29; thence with the line of Lots 14, 13 and 6, N. 47-08 W. 190 feet to a point on the South side of Mayflower Street, joint front corner of Lots 6 and 7; thence along the South side of Mayflower Street, S. 42-52 W. 105 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to us by A. E. Holton by deed dated September 21st, 1950 and recorded in the R. M. C. office for Greenville County in Vol. 419, at page 516."
