"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, lying on the West side of a County Road, in Little Texas Community, and bounded by lans of James Keeler, W. J. I. Edwards and other land of P.M. Johnson containing 0.41 acre, more or less, and having the following metes and bounds:

"BEGINNING at an angle iron, formerly a persimon, corner for lands of P.N.
