Homer Styles, his Heirs and Assigns: All that piece, parcel or lot of land situate, lying and being in Greenville County, in O'Neal Township, State of South Carolina, near Double Springs Church, lying on the North side of the McCalhaney Road, being bounded on the West by lots of C. J. Collins, now deceased, on the North and East by other lands of Clinton Jones Collins, and being a part of the same land conveyed to Mortgagor by Julius T. Dill, by deed dated December 18, 1942, recorded in Deed Book 250 at Page 135, and having the following courses and distances to wit:
