MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, J. E. Sparks

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-Six Hundred Two and 33/100

DOLLARS (\$ 2602.33),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$50.00 on November 14, 1953, and a like payment of \$50.00 on the 14th day of each month thereafter until paid in full, said payments to be applied to principal, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, IN BATES TOWNSHIP, on or near the Pleasant View Welcome Road, which road is approximately one-half mile north of the White Horse Road, and having according to a plat of W. A. Hester dated November 30, 1940, the following metes and bounds:

"BEGINNING at a stone on the bank of the Pleasant View Welcome Road, and running thence across said road, N. 15 W. 11 chains to poplar X3; thence N. 85½ W. 17.04 chains to a pine X3NM; thence N. 46 W. 11.37 chains to iron pin; thence N. 88 W. 3.11 chains to iron pin; thence S. 5 E. 6.11 chains to a small P.O. X3NM; thence S. 58½ E. 15.15 chains to iron pin; thence S. 75 E. 14.44 chains to iron pin on the Pleasant View Welcome Road; thence S. 60 E. 4.30 chains to stone on the bank, the beginning corner. Containing 21.15 Acres, more or less, and being the same property conveyed to the mortgagor by J. D. Brookshire by deed recorded in Volume 289 at Page 476."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
