, with interest thereon from date

at the rate of six per centum per annum, to be computed and paid monthly

until paid in full: all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid. the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage: and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that certain piece, parcel or tract of land, situate, lying and being in the State of South Carolina, County of Greenville, andim Chicks Springs Township, on the S/s of Paris Mountain Road and on the S/s of Mountain Creek, being composed of two separate tracts of land and containing 5.93 acres, more or less, and having, in the aggregate, the following metes and bounds to wit:

BEGINNING at a point in the center of the bridge on the Faris Mountain Road over Mountain Creek, and running thence along the center of said Paris Mountain Road (also being known as State Highway No.253), almost due south, 9.50 chains to a point in the center of said road; thence N. 38.
