City of Greenville, with the buildings and improvements thereon situate, lying and being at the northwest corner of the intersection of Rutherford Street and Echols Street, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwest corner of Rutherford Street and Echols Street and running thence with Echols Street, S. 67-30 W. 105 feet to an iron pin, W. A. Hudson's corner; thence with Hudson's line, N. 8-45 W. 59.5 feet to an iron pin; thence in a northeasterly direction along Beaty's line, 116.8 feet to a stake on Rutherford Street; thence with Rutherford Street, S. 1-30 W. 60.5 feet to the point of beginning.
