All that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, on the East side of Crest Street, near the City of Greenville, known and designated as Lot No. 27 on plat of the property of Victor-Monaghan Company, Development No. 1 made by Dalton & Neves, Engrs. December 1941 and recorded in the R. M. C. Office for Greenville County in Plat Book "M", at page 39 and having, according to said plat, the following metes and bounds, to-wit:
