Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina: in the City of Greenville, being known and designated as lot No. 31, as shown on a plat of University Circle, recorded in Plat Book Y at Page 111, and according to a more recent survey prepared by R. W. Dalton in October 1903, is described as follows:

BEGINNING at an iron pin on the Eastern side of Blythwood Drive, which pin is 316.5 feet Southeast from the intersection of Blythwood Drive with Carpbell Street, at the joint front corner of lots 31 and 32, and running thence with line of lot 32, N. 67-34 E. 124.5 feet to an iron pin in line of lot 40; thence with line of lots 40 and 41, S. 24-56 E. 60.5 feet to an iron pin, rear corner of lot 30; thence with line of lot 30, S. 63-15 W. 121 feet to an iron pin on the Eastern side of Blythwood Drive; thence with the Eastern side of Blythwood Drive, N. 29-21 W. 70 feet to the point of beginning.
