Dollars to me the said mortgagor— in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and
Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in (former) School District 9-A, at Pleasant Grove near Greer, lying on the northeastern side of the Buncombe Road (to Pelham), and designated as lot #4 on plat of the property of Moss 0. and Zobedia Black, prepared by W. P. Morrow December 1952, and having the following courses and distances, to wit:-
