To All Whom These Presents May Concern:

Local Home Builders, Inc. SEND GREETINGS:
WHEREAS, the said Local Home Builders, Inc., a corporation with its principal
place of business in Greenville, S. C.
n and by <u>its</u> certain promissory note, in writing, of even date with these presents <u>is</u> well and cruly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the
full and just sum of Four Thousand, Five Hundred and No/100 (\$ 4,500.00)
Dollars, with interest at the rate of six $(6\%)$ per centum per annum, to be repaid in installments of
Forty-Five and No/100 (\$\frac{45.00}{})\$ Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

C. Jones, C. E., December, 1952, and recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 84, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Stokes Street, joint front corner of Lots 13 and 14, and running thence along the joint line of said lots, N. 85-53 E. 163.3 feet to an iron pin on the line of Mattie C. Wright; thence along her line, N. 2-50 E. 23.2 feet to an iron pin; thence continuing along her line, N. 8-50 E. 51.8 feet to an iron pin at the rear corner of Lot 15; thence along the line of that lot, S. 85-04 W. 177 feet to an iron pin on the eastern side of Stokes Street; thence along the eastern side of Stokes Street, S. 3-30 E. 71.8 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
