All that certain parcel or lot of land containing 6.60 Acres, more or less, situated on the east side of State Highway No. 14 at Mosteller's Mill, about 3 miles northward from the City of Greer; in Oneal Township, Greenville County, State of South Carolina, designated as Tract No. 8 of the Mamie M. Burnett Estate, Plat No. 1, according to survey and plat by J.Q. Bruce, Surveyor, dated October 24, 1953, and having the following courses and distances, to wit:
