NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, on the northeast side of Park Avenue or Fleming Drive in the City of Greer, being the greater portion of Lot No. 6 and a small triangle from Lot No. 5 of the W.H. Brockman Estate, plat by Dalton and Neves, Engineers, recorded in Plat Book H, page 132, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning on an iron pin on the northeast side of said Park Avenue, of Fleming Drive, a distance of 326 feet from old U.S. Highway No. 29 (now State Highway No. 290), and running thence with the line of the lot of Catherine B. Sanders, N. 62.19 E. 124.4 feet to an iron pin on the line of I.P. Few's property and in the fork of a China berry tree; thence with the Few line, N. 26.05 W. 90 feet to an iron pin on said line; thence S. 58.15 W. 129.5 feet to an iron pin on the northeast side of said Park Avenue; thence along the edge of same, S. 29.06 E. 80 feet to the beginning corner.
