MORTGAGE OF REAL ESTATE COUNTY OF Greenville To All Whom These Presents May Concern: I, Bessie Evans, of Greenville County, SEND GREETINGS: WHEREAS, I the said in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of One Thousand, Eight Hundred and No/100 - - - - (\$1,800.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Eighteen and No/100 - - - - - - - - - (\$ 18.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear. in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the western side of the Old Paris Mountain Road and known and designated as Lot No. 1 on plat of the property of James L. Love made by W.J. Riddle on June 9, 1943 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of the Old Paris Mountain Road at the corner of lot heretofore conveyed to Olar Gilliard, and running thence with the line of the Gilliard lot, S. 71-02 W. 163.8 feet to an iron pin on a 12-foot alley; thence with the eastern side of said alley, N. 6-30 W. 55.4 feet to an iron pin, corner of Lot No. 2; thence with the line of said lot, N. 72-30 E. 152 feet to an iron pin on the Old Paris Mountain Road; thence with the western side of said road, S. 18-45 E. 50 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Otto Evans and Willie P. Evans by deed dated May 4th, 1953 and recorded in the R. M. C. office for Greenville County in Vol. 480, at page 87."
