| in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Two Thousand, Five Hundred and N. (100) |
| full and just sum of Two Thousand, Five Hundred and No/100 (\$2,500.00) five (5%) Dollars, with interest at the rate of six/(6%) per centum per annum, to be repaid in installments of |
| Twenty-Five and No/100 (\$ 25.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear. |

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me.,

the said Dr. L. B. Sims in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, on the east side of Wilkins Alley, now known as Dobbs Street, and according to a plat of the property of J. Fred Ashmore, et al. prepared by C. O. Riddle, Reg. L. S., in July of 1953 and recorded in the R. M. C. office for Greenville County in Plat Book FF, at page 120, having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of Wilkins Alley at the northwest corner of property now or formerly belonging to Henry Drummond, and running thence along the line of the Drummond property, N. 85-16 E. 66 feet to an iron pin in line of property of Alfarata C. Downs; thence with said Downs property, N. 9-09 E. 46 feet to an iron pin at the corner of property heretofore conveyed by Fred Ashmore to Helen B. McDaniel, et al.; thence along the line of that property, N. 80-32 W. 50.1 feet to an iron pin at the northeast corner of a strip formerly comprising a 13-foot alley (the northern extremity of which is now closed); thence along said alley, S. 22-22 W. 62.9 feet to the beginning corner.

"All all my right, title and interest in and to the alley known as Wilkins Alley both in its present and former location abutting the above property on the west side thereof.
