NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Verner Springs, Greenville Township, and being shown as the Northern half of Lots 142, 143 and 144, less 2 feet of Lot 144 as shown on plat recorded in Plat Book "A" at Page 177 and being more particularly described as follows:

Street formerly Briggs Avenue and Ansel Street and running thence with the Southern side of Ansel Street in a Northeastern direction 150 feet to pin; thence in a line parallel with Bailey Street in a Southwestern direction 50 feet to iron pin; thence in a line through Lots 143, 144 and 145, 150 feet to iron pin on the Eastern side of Bailey Street; thence with the Eastern side of Bailey Street in a Northern direction, 50 feet to point of beginning.
