All that certain parcel or lot of land situated on the west side of the Mosteller Road, near the limits of the City of Greer and northward therefrom, in Chick Springs Township, Greenville County, State of South Carolina, containing 2.20 Acres, more or less, and having the following courses and distances, to wit:

Beginning at a nail in the center of the Mosteller Road (now State Highway No. 14), corner of Wilson Graveyard property, and running thence along said highway, N. 47.00 W. 627 feet to a point in center of same; thence N. 80.35 W. 74 feet to an iron pin; thence S. 7.15 E. 100 feet to iron pin in the old abandoned Mosteller Road; thence along the center of said old road bed, S. 21.45 E. 311.3 feet to an iron pin, corner of the cemetery lot; thence with line of same, N. 81.10 E. 88 feet to iron pin, S. 48.39 E. 110.7 feet to iron pin, and N. 87.51 E. 233.5 feet to the beginning corner.
