"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southwest side of Buncombe Street, in the City of Greenville, being shown as lot No. 3, Section 3, Page 14 of the City Block Book, and described as follows:

"BEGINNING at an iron pin on the Southwest side of Buncombe Street, corner of lot now or formerly owned by Gulf Refining Company, and running thence with line of the lot of Gulf Refining Company, S. 55-35 W. 46.5 feet to iron pin; thence continuing with line of Gulf Refining Company, N. 68-37 W. 35.2 feet to pin on Butler Avenue; thence with the Eastern side of Butler Avenue, S. 21-23 W. 71.1 feet to iron pin; thence S. 64-27 E. 53 feet to iron pin; thence N. 8-10 E. 46 feet to iron pin; thence N. 55-35 E. 50.9 feet to iron pin on Buncombe Street; thence with the Southwestern side of Buncombe Street, N. 33-0 W. 21 feet to the point of beginning."
