having, according to survey of property of Nathan P. Whitmire  
by R. E. Dalton dated February 15, 1911, and recorded in the  
R.M.C. Office for Greenville County, S. C., in Plat Book A,  
page 455, the following metes and bounds, to-wit:

BEGINNING at a stake on the East side of Augusta Street;
