"BEGINNING at an iron pin on the west side of Crain Avenue at the intersection of Crain Avenue and Marion Road, and running thence with Marion Road, S. 50-30 W. 146.5 feet to an iron pin in line with Lot No. 114; thence with the line of Lot 114, N. 28-30 W. 148 feet to an iron pin in line with Lot 110; thence with the line of Lot 110, S. 50-30 W. 50.7 feet to an iron pin in line with Lot 115; thence along line of Lot 115, N. 28-30 W. 47.7 feet to an iron pin at the rear corner of Lots 109 and 110; thence with the joint line of said lots, N. 52-30 E. 229.9 feet to an iron pin on the west side of Crain Avenue; thence along Crain Avenue, S. 18-08 E. 200 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
