Gresham, Jr. Borrower, (whether one or more) aggregating Five Thousand Two Hundred Ninety Seven and 00/100 Dollars (\$ 5297.00), (evidenced by note(s) dated Nov. 11, 19 53, hereby expressly made a part hereof) and to secure said advances, and any additional advances (not exceeding an equivalent amount) that may subsequently be made to Borrower by Lender, to be evidenced by promissory notes, all renewals and extensions thereof, with interest until paid as provided in said note(s), and costs, including a reasonable attorneys' fee of not less than ten per centum (10%) of the total amount due thereon and charges, as provided in said note(s) and herein, undersigned has granted, bargained, sold, conveyed and mortgaged, and by these presents does hereby grant, bargain, sell, convey and mortgage in fee simple unto Lender, its successors and assigns: All that tract of land located in Austin Township, Greenville County, South Carolina, containing 112 acres, more or less, known as the Gresham place, and bounded as follows:

On the North by S. T. Holland, on the East by J. P. Looper, on the South by P. A. Moore, Cannon Gresham, the estate of Carrie L. Sloan and George Leake, and on the West by J. H. Stokes and being fully set forth by courses and distances and metes and bounds on a plat made by W. J. Riddle, Surveyor, under date of January 26, 1952, which said plat is recorded in Greenville County in Plat Book X, Page 28,. The said tract of land was conveyed to J. O. Gresham, Jr. by F. Allen Gresham, Executor and Nellie Gresham Kilgore, Executrix, of the estate of J. O. Gresham, deceased, by deed dated August 17, 1946, recorded in Deed Book 297, Page 417, in the office of R. M. C. in Greenville County, South Carolina

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said lands and premises unto Lender, its successors and assigns, with all the rights, privileges, members and appurtenances thereto belonging or in any wise appertaining.

UNDERSIGNED hereby binds himself, his heirs, executors, administrators and assigns to warrant and forever defend all and singular the said premises unto Lender, its successors and assigns, from and against Undersigned, his heirs, executors, administrators and assigns and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.

PROVIDED ALWAYS, NEVERTHELESS, that if Borrower shall pay unto Lender, its successors or assigns, the aforesaid indebtedness and all interest and other sums secured by this or any other instrument executed by Borrower as security to the aforesaid indebtedness, and shall perform all of the terms, covenants, conditions, agreements, representations and obligations contained in a certain recorded Chattel Mortgage and/or Crop Lien executed by Borrower to Lender according to the true intent of said Chattel Mortgage and/or Crop Lien, all of the terms, covenants, conditions, agreements, representations and obligations of which are made a part hereof to the same extent as if set forth in extenso herein, then this instrument shall cease, determine and be null and void; otherwise it shall remain in full force and effect.
