NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of Arch Street Extension, being known and designated as all of Lot 9 and the Eastern half of Lot 8 on plat of the property of F. B. Massingale, recorded in Plat Book W at Page 109 and being more particularly described as follows:

BEGINNING at a stake on the Northern side of Arch Street Extension at Lot 10 and running thence with the line of Lot 19, in a Northwesterly direction 160 feet; thence S. 60-40 W. 90 feet to a stake in rear line of Lot 8; thence through the center of Lot 8 in a Southeasterly direction 160 feet to a stake on North side of North Street Extension; thence along the Northern side of Arch Street N. 60-40 E. 90 feet to the point of beginning.

Said premises being the same conveyed to the Mortgagor by Willie Harvey and Lois Harvey, by deed to be recorded herewith.
