To All Whom These Presents May Concern:

Local Home Builders, Inc. SEND GREETINGS:

WHEREAS, the said Local Home Builders, Inc., a corporation with its principal place of business in Greenville, S. C.

in and by its certain promissory note, in writing, of even date with these presents is well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Four Thousand, Eight Hundred and No/100 - - - (\$ 4,800.00)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of

Forty-Eight and No/100 - - - - - (\$ 48.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That, the said Local Home Builders, Inc.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to

the said Local Home Builders, Inc. in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, being known and designated as Lot No. 54 according to a plat of Belmont Heights prepared for Local Home Builders, Inc. by C. C. Jones, C. E., June, 1953, said plat at this time being unrecorded, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Cool Brook Drive, joint front corner of Lots 54 and 55, said pin being approximately 280 feet from the intersection of Cool Brook Drive with Kay Drive, and running thence with the line of Lots 54 and 55, in a southwesterly direction, 170 feet to an iron pin in the center of a branch; thence following the meanders of said branch, in a general northerly direction until it reaches an iron pin at the joint rear corner of Lots 53 and 54; thence with the joint line of said lots, in a northeasterly direction, 171 feet to an iron pin on the west side of Cool Brook Drive; thence with Cool Brook Drive, in a southeasterly direction, 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to mortgagor corporation by Henry J. Winn by deed dated February 4, 1953 and recorded in the R. M. C. office for Greenville County in Vol. 471, at page 382."
