

, a corporation organized and existing under the laws of , hereinafter the State of South Carolina called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eight Thousand, Eight Hundred and No/100 ---- Dollars (\$ 8,800.00 ), with interest from date at the rate of Four & One-Half per centum (4 %) per annum until paid, said principal and interest being payable at the office of GENERAL MORTGAGE CO. , or at such other place as the holder of the note may Greenville, South Carelina designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-Eight and 92/100 - - - - - - - Dollars (\$ 48.92 ), commencing on the first day of , 19 54, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April , 19**79** .

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that lot of land with the buildings and improvements thereon, situate on the northwest side of North Estate Drive, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 42 on plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Page 189, said lot fronting 65 feet along the northwest side of North Estate Drive, and running back to a depth of 165.3 feet on the northeast side, to a depth of 179.3 feet on the southwest side and being 75 feet across the rear.

The above described property is the same conveyed to the mortgagors herein by deed of W. L. Miller, Jr., of even date and to be recorded herewith.

"Should the Veteran's Administration fail or refuse to issue its guaranty of the loan secured by this instrument under the provisions of the servicemen's readjustment act of 1944, as amended, within sixty days from the date the loan would normally become eligible for such guaranty, the mortgagee herein may, at its option, declare all sums secured hereby immediately due and payable."

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
