"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southeastern corner of the intersection of White Horse road and Durham street, in Greenville Township, being shown as all of lot 21 and portions of lots 20 and 22 on plat of the property of Bertie E. Burns, recorded in Plat Book G. at page 30, in the R.M.C. office for Greenville County, and having the following courses and distances to wit, when described as a whole, to wit:
